### 2. Qualifications

- 1) Must comply with the Gifted Education Promotion Law, Article 25 (Supporting documents required)
- 2) No disqualifying reasons for employment according to the followings;
  - The Public Educational Officials Act, Article 10, Section 3 or Section 4
  - The State Public Officials Act, Article 33
  - Act on the Protection of Children and Juveniles from Sexual Abuse Article 56.
- 3) No disqualifying reasons from health check results
- 4) Must have completed or been exempted from mandatory military service (Korean nationals only)
- 5) Advanced Degrees in the fields with the ability to lecture in English
  - **Required: PhD. in mathematics**
  - **Required: PhD in philosophy/ Master's Degree in philosophy with at least 5 years relevant teaching experiences**
- 6) Both Korean and foreign applicants are eligible.

### 4. Recruitment Process

- 1) Document review
- 2) Teaching demonstration (in English) followed by faculty interview (On-site).
- 3) KSA Teachers' Advisory Personnel Committee's interview
- 4) KSA Teachers' Personnel Committee's review
- 5) Notice on final successful candidates : Early July

### 5. Required Documents

- 1) Document Screening
  - Application form (KSA provided format), 1 copy
  - Curriculum Vitae (Signed by the applicant), 1 copy
  - Two letters of recommendation including one from the applicant's research advisor  
(The letters of recommendation should be directly sent to KSA via email or mail.)
- 2) Teaching demonstration (in English) followed by faculty interview (on-site) (For applicants who successfully pass the document review).
  - University (Major) transcripts, 1 copy
  - Proof of final degree in relevant field, 1 copy
  - Documented proof of educational career (as listed on the application form)
  - Documented proof of research activities (as listed on the application form)
    - ※ Final thesis, 1 copy
    - ※ Results of research performed within the last 5 years

## 7. Other Details
